RULES AND REGULATIONS

1. **QUIET TIME** is 10:00 pm to 8:am Sunday through Thursday, 11:00 pm to 8:00 am Friday and Saturday. **THESE TIMES will be strictly enforced.**
2. **ALL PETS** must be on a leash at all times and there must be someone **IN ATTENDANCE** so that their pet does not get loose or is noisy. Please put your **PET INSIDE** if you will be away for the day, or for any extended length of time.
3. **NO DOGS** on Main Beach at any time.
4. **IT IS MANDATORY** that Pet Owners pick up and properly dispose of their pet's feces. This will be strictly enforced.
5. **ALL GARBAGE** must be deposited into garbage bins and bottles into recycling barrels.
6. Maximum of **2 VEHICLES** per site unless okayed by office.
7. **CAMPITES MUST BE CLEANED** before leaving.
8. **SPEED LIMIT** in Campground is **10 KPH** on Mink Lake Property and also on the Lake. There will be **ABSOLUTELY NO MOTOR BIKES, QUADS, SEA-DOOS** etc. allowed on MinkLake Property. For the **SAFETY** of our **LITTLE ONES** please do not allow children to ride holding on to the back of golf carts.
9. **SWIMMING** is at your own risk. **NO LIFEGUARDS ON DUTY.** It is advisable to have all small children wear life jackets if they are playing near the water and to not leave them unattended.
10. **GATE WILL CLOSE** at Store Hours and open at Store Hours.
11. Mink Lake is **NOT RESPONSIBLE** for any damage or theft during your visit.
12. **CUTTING DOWN** any live or dead trees or shrubs is not permitted.
13. **FIRES** are restricted to fire pits only. Fires must be put out before leaving.
14. **MINK LAKE IS NOT RESPONSIBLE** or liable for injuries that may occur on Mink Lake property.
15. **ALCOHOL** is allowed within the campsites only.
16. **NO ALCOHOL** on beach, common areas or with Day Use Passes.
17. **NO FIRE WORKS PERMITTED**

If for any reason the rules and regulations are not being followed, Mink Lake has the right to ask you to leave without reimbursement. If you are unable to drive due to being intoxicated, we will have the police escort you off the campground.

HOLD HARMLESS AGREEMENT

The signee ,(hereinafter called "Camper"), jointly and severally, in consideration of being permitted to enter onto, use or occupy properties or facilities belonging to or under the control of Mink Lake Resort and Campground(1988) Inc. (hereinafter called "Mink Lake Resort") and such other consideration, such consideration acknowledged as received and sufficient, does hereby agree to waive, release absolutely, indemnify and save harmless Mink Lake Resort, it's servants, employees, officers, directors,contractors, volunteers and agents from and against all claims, demands, awards, judgements, costs (including legal costs), actions, causes of action and proceeding by whomever made or brought in respect of of any personal or bodily injury (including death) to any person, and any loss of or damage to any property caused directly or indirectly by or as a result of the Camper, or it's family, friends, guests, acquaintances, agents, servants, contractors, employees or any person connected with the Camper, directly or indirectly, expressly or implied, regardless of whether the Camper related person was invited or not, and regardless of whether the Camper is not at Mink Lake.

The terms of this Agreement form shall be construed as the entire agreement and may not be altered, amended or modified except in writing and signed by all parties hereto. The terms of this Agreement shall be governed by the Laws of the Province of Alberta. This Agreement shall continue to be in full force and effect for each and every visit to Mink Lake Resort by the Camper, their family, friends, guests, acquaintances, agents, servants,contractors,employees, or any person connected with the Camper, directly or indirectly,expressly or implied, regardless of whether the Camper related person was invited or not, and regardless of whether the Camper is present or not at Mink Lake Resort.
